

# How to Generate Conflict Check Report

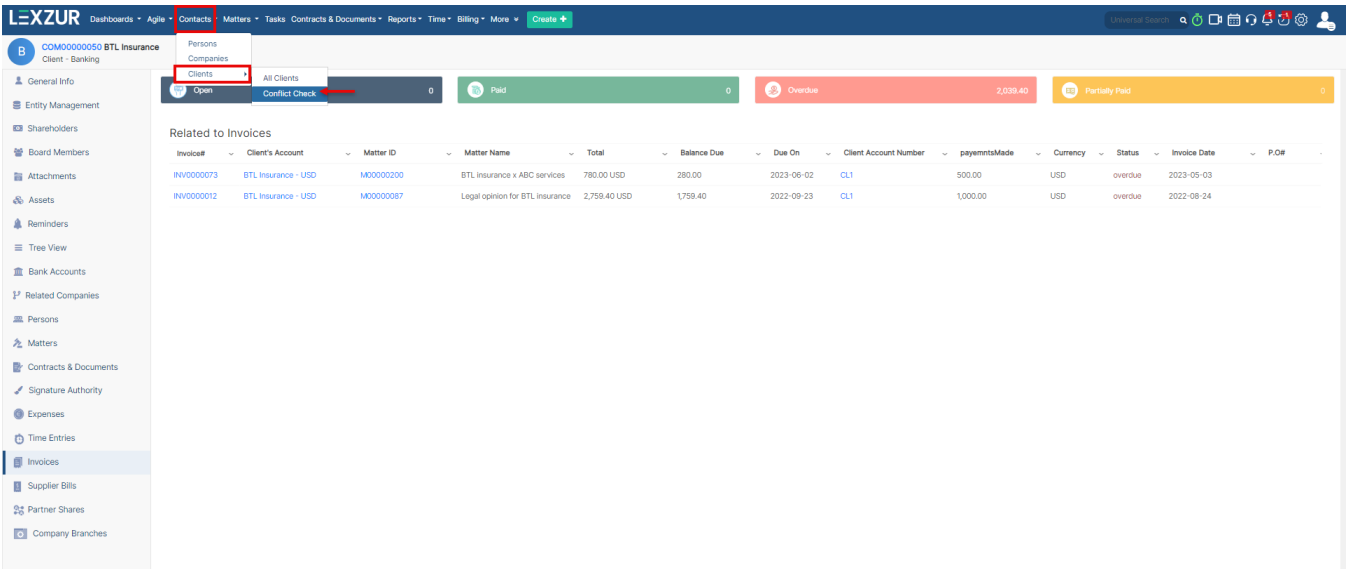
## Objectives

- Check the conflict of interest of a company/person

## Steps

The Conflict Check tool allows you to efficiently check for any conflicts of interest with a particular contact.

To generate a conflict check report, you can conveniently access it directly from the **Clients** page under the **Contacts** module.



Simply choose the specific contact you wish to assess for conflicts, whether it be an individual or a company. Enter the name and initiate the search.
